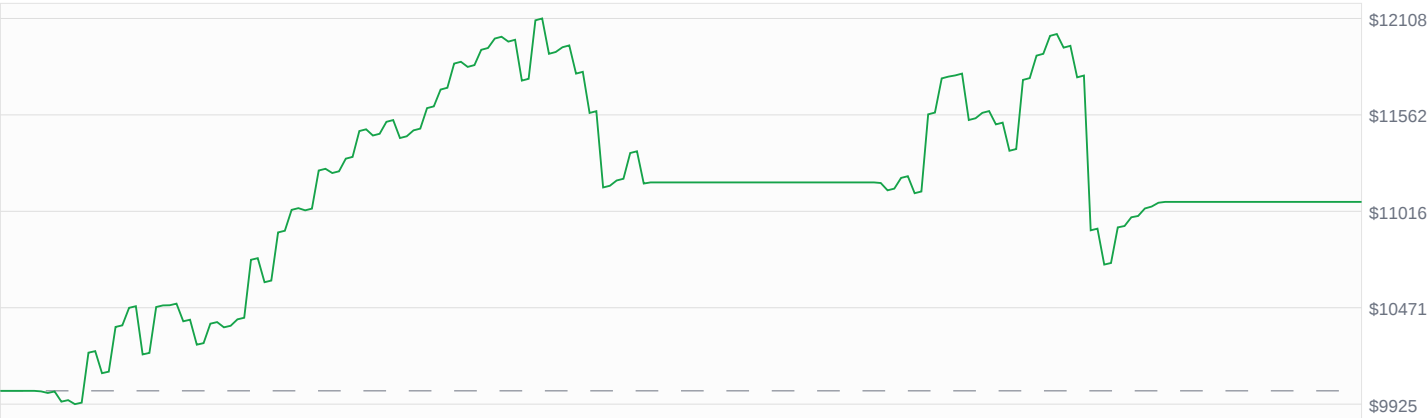

The +10.70% return on AAPL is statistically meaningless due to the n=2 sample size, which renders the 0.87 Sharpe ratio and 50% win rate unreliable for future performance. The 11.50% max drawdown suggests significant volatility risk relative to the modest gain, indicating poor risk-adjusted efficiency in this specific simulation. This result lacks the statistical confidence required for institutional deployment or capital allocation decisions. Extend the backtest to a minimum of 100 trades across multiple market regimes to establish a robust performance baseline before proceeding.
