Hera local LLM

The +41.20% ROI and 100% win rate look impressive but are statistically meaningless with only two trades, offering zero confidence in strategy robustness. A 32.83% max drawdown on such a tiny sample suggests high volatility and potential overfitting to specific market conditions rather than genuine alpha. The 1.21 Sharpe ratio is irrelevant here, as it requires a larger dataset to be reliable. This backtest proves nothing beyond a lucky streak, so the immediate next step is to run a walk-forward analysis on at least fifty trades to validate consistency.
