ANALYST NOTE

Hera local LLM

The strategy generated a 29.90 percent ROI with a perfect win rate, but only two trades provide no statistical confidence. A Sharpe ratio of 1.34 is misleading given the tiny sample size. The 17.75 percent max drawdown is disproportionately high relative to the profit, indicating poor risk management. This backtest is statistically meaningless and likely overfitted. Extend the simulation to at least one hundred trades before considering deployment.
