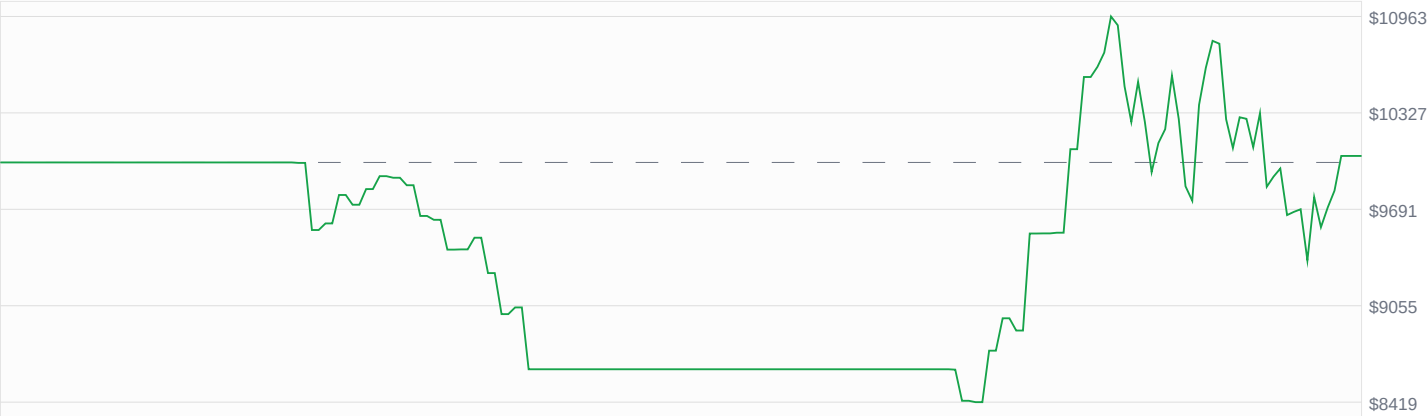

ANALYST NOTE

Hera local LLM

The EVO_EVOEVOEVOE_v1926 backtest on PLMR shows a nominal +0.43% return with a 50% win rate, but the metrics lack statistical significance. With only two trades executed, the Sharpe ratio of 0.14 and the 14.67% maximum drawdown are too volatile to draw reliable conclusions about strategy robustness. The sample size is insufficient to validate the risk-adjusted performance, rendering any observed profit potentially a statistical outlier rather than a consistent alpha. We must run a longer backtest period or optimize parameters to generate a larger trade history before assessing viability.
