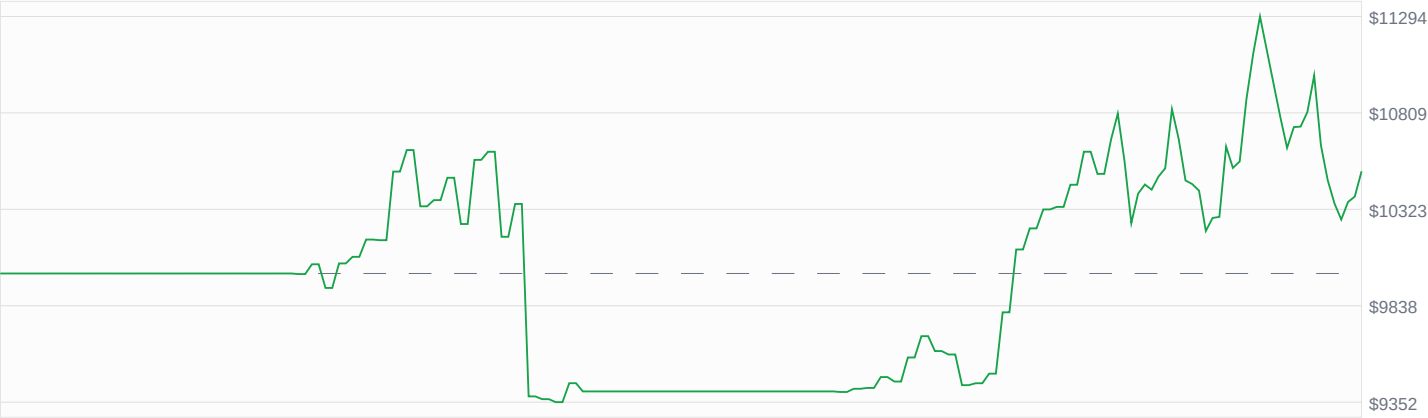

Hera local LLM

The AX backtest shows a +5.11% return, but the 50% win rate and 0.43 Sharpe indicate a lack of statistical edge. With only two trades, the results lack confidence, and an 11.24% drawdown reveals significant instability in the GG7 Williams signal logic. The strategy fails to filter noise effectively, turning a potential mean-reversion setup into a high-variance gamble. You must expand the sample size through longer historical testing before deploying live capital.
