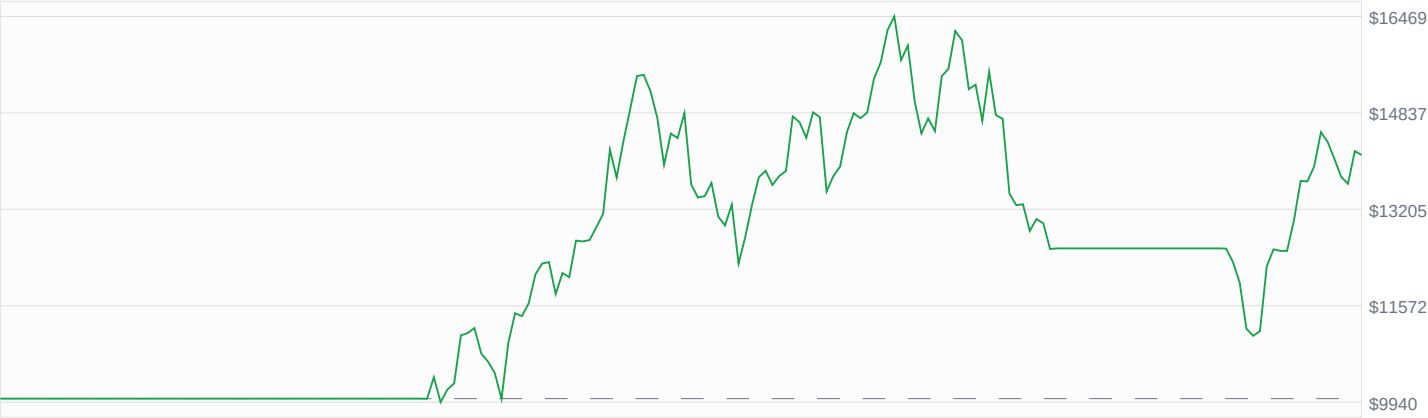

ANALYST NOTE

Hera local LLM

A 100% win rate on just two trades is statistically meaningless, not proof of alpha. The +41.20% ROI masks a severe 32.83% drawdown, indicating high volatility and poor risk control. A Sharpe ratio of 1.21 is unreliable with such a tiny sample size, offering zero confidence in long-term stability. This strategy lacks robustness and fails to demonstrate consistent edge. Next step: run a minimum of 100 trades across multiple market regimes to validate true performance.
