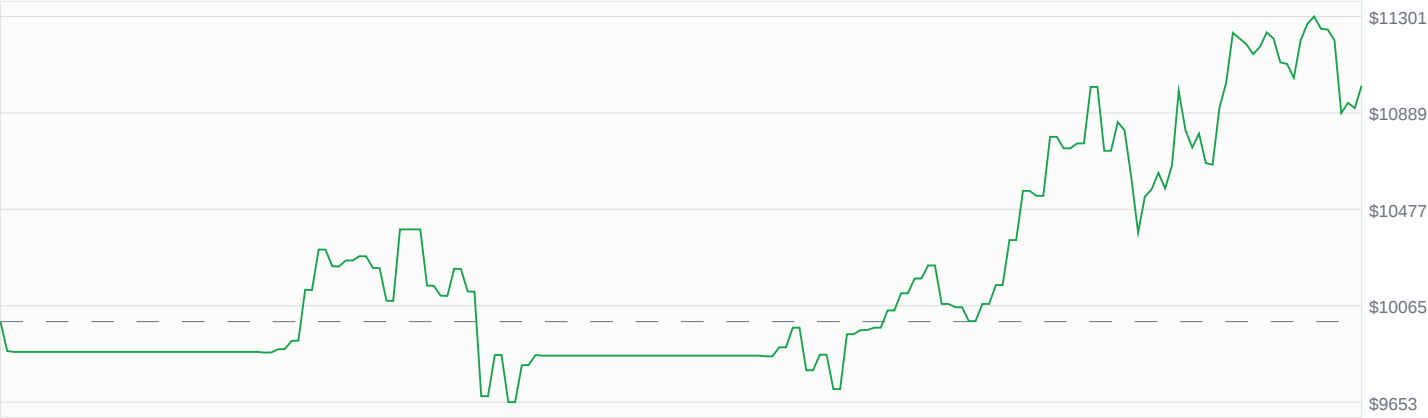

ANALYST NOTE

Hera local LLM

This strategy's performance is statistically insignificant due to only three trades, rendering the 10% ROI and 0.94 Sharpe ratio unreliable noise rather than alpha. The 33.3% win rate contradicts the positive returns, suggesting the few successful trades carried disproportionate size or the sample is too thin to assess risk accurately. A 6.54% drawdown indicates meaningful volatility, but we cannot determine if the drawdown limit is appropriate without a larger dataset. The next logical step is to run a longer backtest or optimize entry parameters to generate sufficient trade volume before deploying capital.
