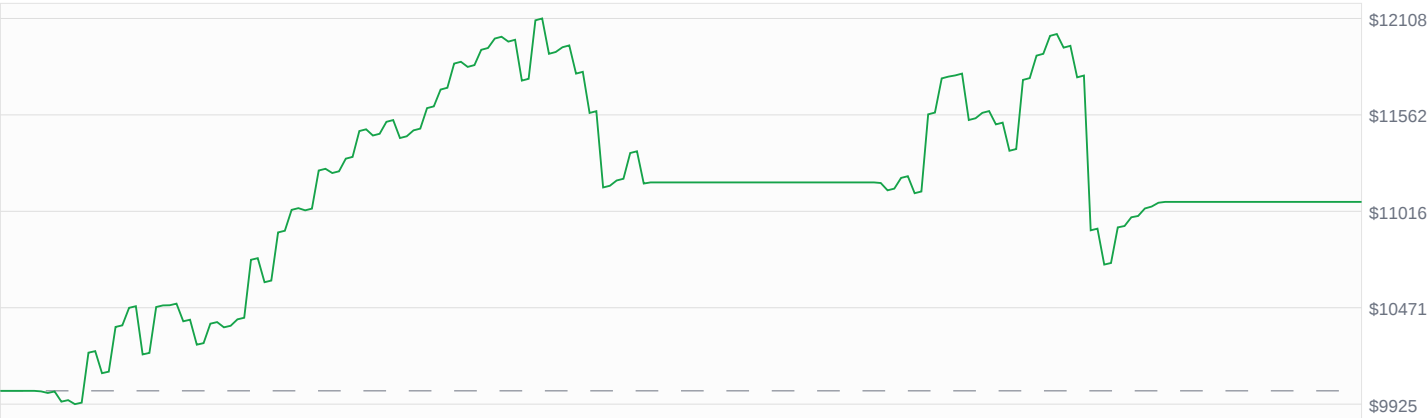

ANALYST NOTE

Hera local LLM

The +10.70% return is driven entirely by two trades, making the 50.0% win rate statistically meaningless due to severe sample bias. A Sharpe ratio of 0.87 is adequate but unverified without a larger dataset, and the 11.50% max drawdown suggests fragile risk controls. This strategy lacks the statistical confidence required for institutional deployment. Run a backtest over at least 500 trades to establish a reliable baseline before considering live execution.
