Hera local LLM

The strategy failed to generate alpha, yielding a negative ROI of -0.63% and a negligible Sharpe ratio of 0.09. With only three trades, the 33.3% win rate lacks statistical significance, making the 23.49% max drawdown an unreliable indicator of true risk. The sample size is far too small to validate the EVOEVOEVOE_v1800 logic or its edge in the NVDA market. You should expand the backtesting period to at least one hundred trades to establish meaningful statistical confidence before further optimization.
