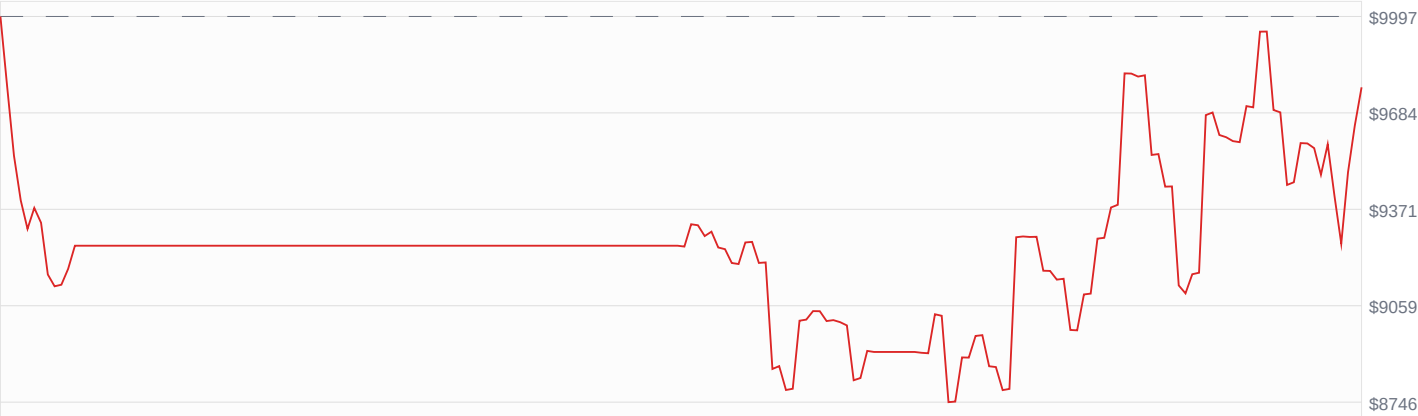

ANALYST NOTE

Hera local LLM

The negative ROI of -2.36% and a Sharpe ratio of -0.09 indicate the MCK Zen Mean Reversion strategy is currently unprofitable. With only three trades, the 33.3% win rate lacks statistical significance, making it impossible to distinguish skill from noise. The 12.54% max drawdown highlights significant downside risk relative to the minimal capital loss. Given the low sample size, any performance metrics are unreliable and do not represent long-term expectancy. The immediate next step is to expand the backtest period to at least one hundred trades to establish a valid baseline before further optimization.
