ANALYST NOTE

Hera local LLM

The strategy exhibits negative alpha with a 33.3% win rate and a 23.49% drawdown, indicating poor risk-adjusted returns. The 0.09 Sharpe ratio confirms the lack of consistent profitability against volatility. Statistical confidence is negligible given only three total trades, rendering the results statistically insignificant. The primary failure is the high drawdown relative to the minimal loss in ROI, suggesting weak stop-loss management. Next step: increase the sample size to at least 100 trades to establish a reliable baseline before further optimization.
