ANALYST NOTE

Hera local LLM

This backtest on GC=F is statistically insignificant due to only three trades, rendering the -4.00% ROI and -0.36 Sharpe ratio unreliable indicators of strategy failure. The 33.3% win rate suggests the entry logic is misaligned with current volatility regimes, while the 12.60% drawdown highlights a critical lack of risk controls during adverse price action. Expanding the sample size through a longer lookback period is required to distinguish between random noise and genuine structural flaws before deploying live capital. Immediate focus must shift to optimizing stop-loss placement and refining the entry filter to reduce frequency of losing positions. Without further data, no definitive conclusion regarding profitability can be drawn for this
