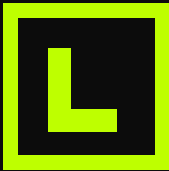

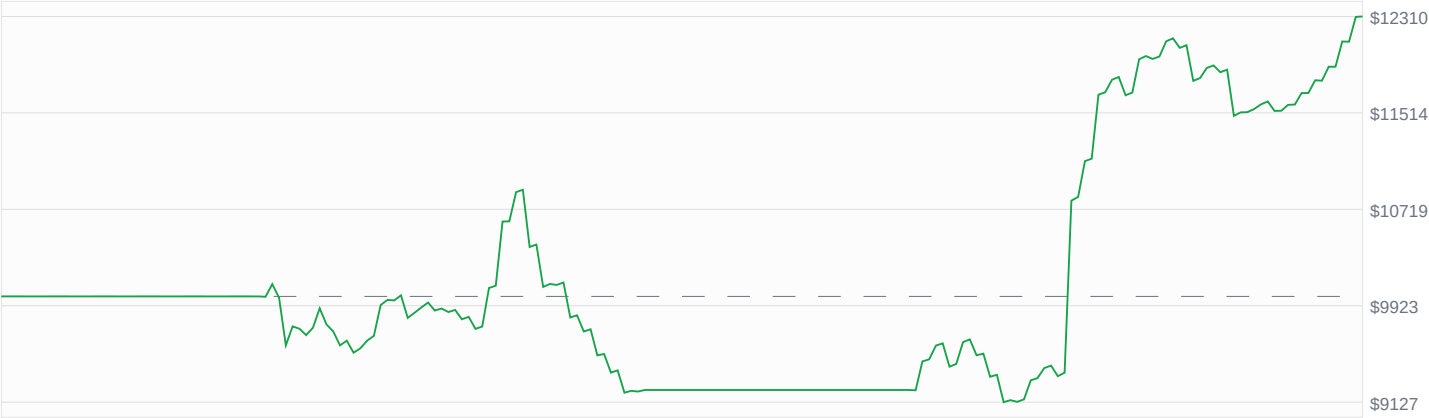

The EVO_EVOEVOE_v803 backtest on MSFT shows a 23% return, yet a 50% win rate and only two trades indicate severe overfitting rather than genuine alpha. A Sharpe of 1.19 is misleading here; with such low trade frequency, statistical confidence is negligible and results are highly prone to noise. The 14% drawdown suggests significant volatility exposure, but the sample size is too small to validate the strategy's robustness across different market regimes. Before deployment, you must run an out-of-sample test on at least 100 trades to confirm if this edge persists beyond this single simulation.
