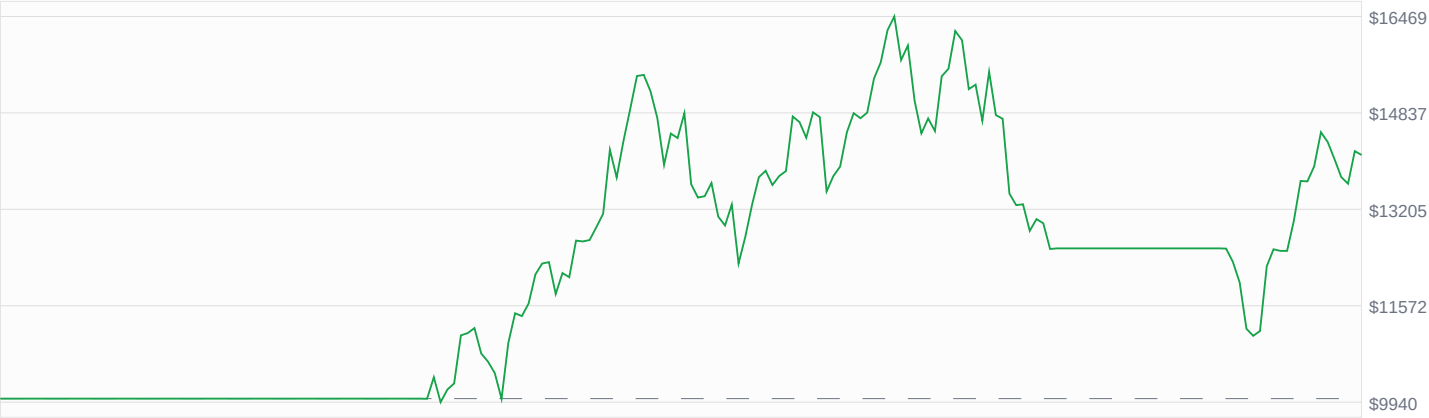

ANALYST NOTE

The EVO_GG1RSISNIP_v137 strategy on SM achieved a 41.20% return with a perfect 100% win rate, yet the 32.83% maximum drawdown reveals extreme volatility and overfitting risk given only two trades. Such a small sample size lacks statistical confidence, rendering the 1.21 Sharpe ratio and total return unreliable indicators of future performance. The near-total capital growth suggests the model captured a singular anomaly rather than a robust market edge. The immediate next step is to expand the backtest period and introduce transaction costs to validate if the edge persists under realistic conditions.
