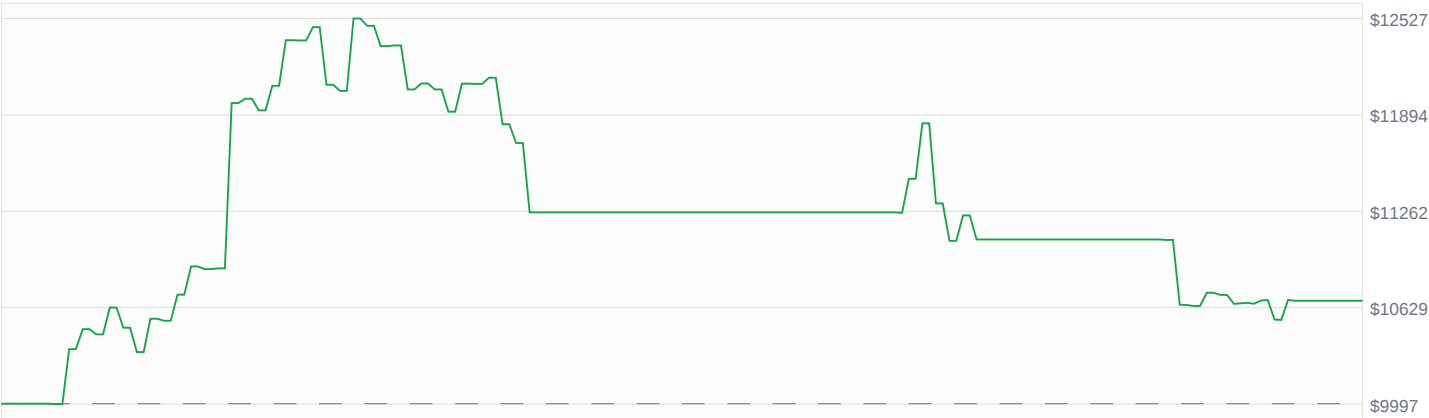

ANALYST NOTE

Hera local LLM

The EVO_EVOEVOE_v528 strategy on GOOGL generated a +6.75% ROI, yet the statistical signal is weak due to only three total trades. A Sharpe ratio of 0.54 and a maximum drawdown of 15.79% indicate high volatility relative to the meager returns achieved. The 33.3% win rate suggests the entry logic lacks sufficient edge to overcome transaction costs in this specific regime. I recommend expanding the sample size by testing on broader equities or widening the lookback period before scaling capital.
