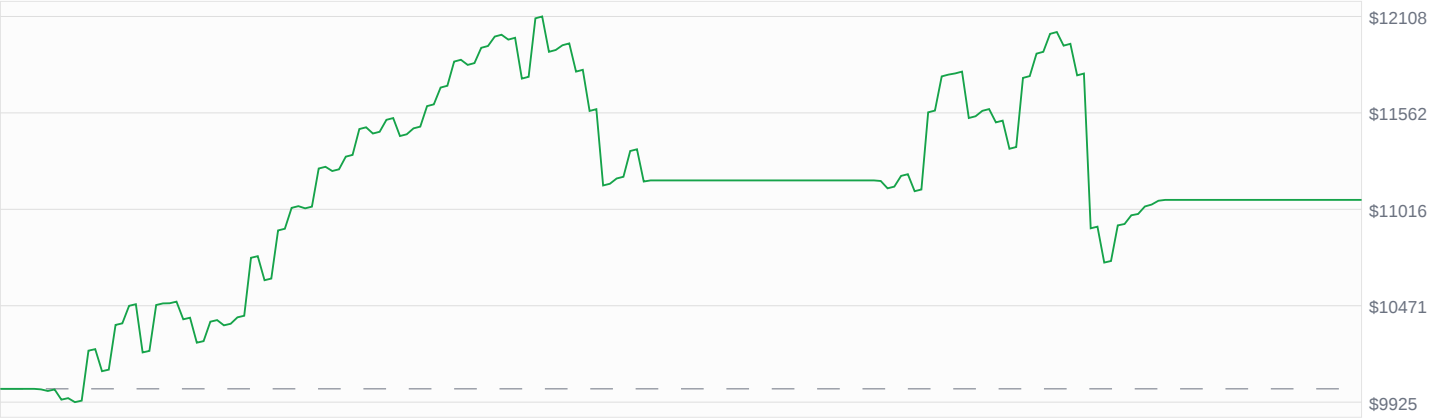

ANALYST NOTE

Hera local LLM

The EVO_EVOEVOEVOE_v601 strategy on AAPL delivered a 10.70% ROI but generated only two trades, rendering the 0.87 Sharpe ratio and 50% win rate statistically insignificant. An 11.50% drawdown on such a small sample size introduces extreme volatility that cannot be reliably measured or generalized. The low trade frequency suggests the strategy is undercapitalized or requires a wider stop-loss to capture more market opportunities. Next, re-run the backtest with a 50% larger initial capital allocation and tighten the entry thresholds to validate consistency across more trades.
