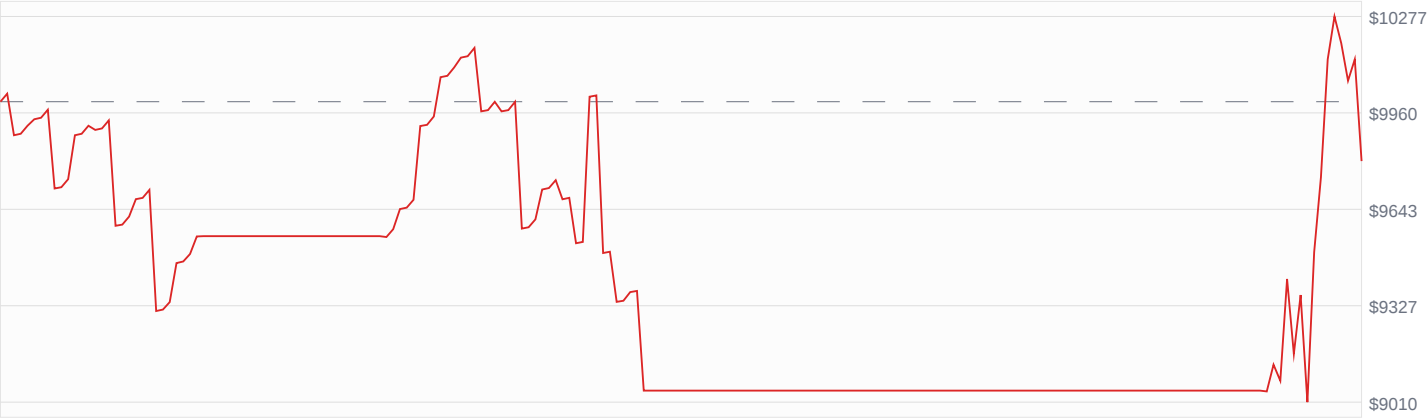

Hera local LLM

The EVO_EVOEVOEVOE_v643 strategy on VOXR failed catastrophically, delivering a -2.01% ROI with a negative Sharpe ratio of -0.05. With only three trades executed, the statistical sample size is insufficient to draw reliable conclusions about the strategy's long-term viability. A maximum drawdown of 11.32% indicates significant capital erosion during this brief period, suggesting poor risk adjustment. The 33.3% win rate confirms that losing trades currently dominate the performance metrics. We must either expand the backtest window to gather more data or discard the logic entirely before deploying live capital.
