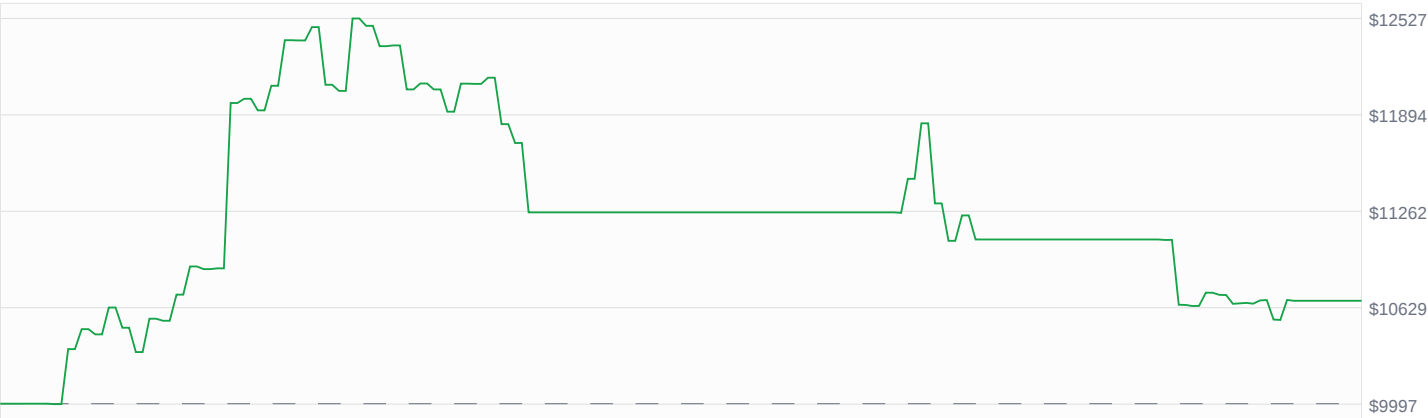

ANALYST NOTE

The EVO_GG1RSISNIP_v1059 backtest on GOOGL generated +6.75% ROI with a 33.3% win rate, yet the extremely low trade count of three renders the 0.54 Sharpe ratio statistically insignificant. The 15.79% maximum drawdown suggests high volatility exposure that a single sample cannot validate, making the performance profile unreliable for live deployment. We must expand the sample size through broader market testing or extended lookback periods to confirm whether this alpha is robust or merely noise. Proceeding with live capital based on these three trades would be premature without further statistical validation.
