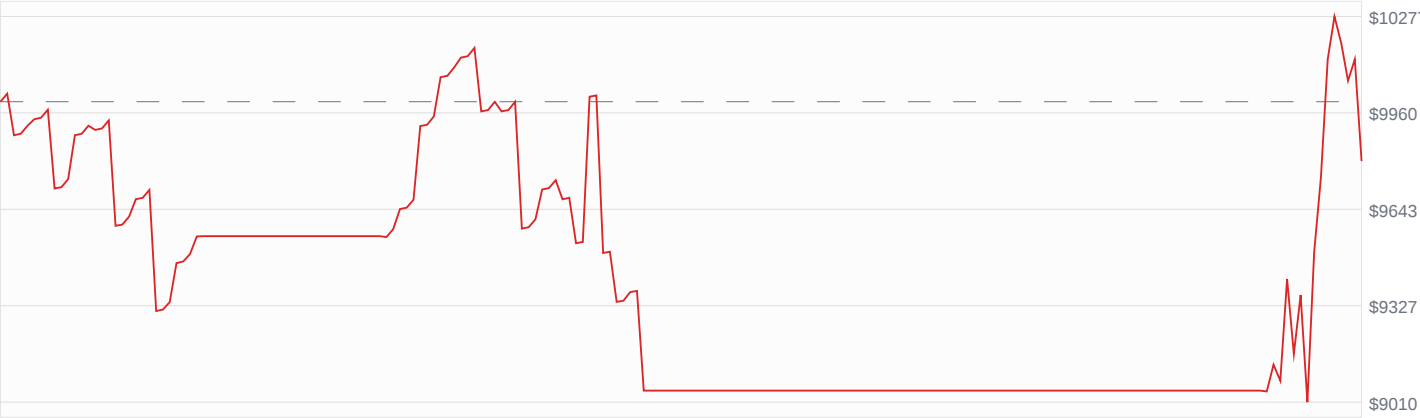

ANALYST NOTE

Hera local LLM

The VOXR backtest for EVO_GG1RSISNIP_v1068 demonstrates severe underperformance, losing 2.01% capital with a negative Sharpe ratio of -0.05. The strategy generated only three trades, resulting in a statistically insignificant sample size that renders the 33.3% win rate and 11.32% drawdown meaningless for live deployment. Such limited data prevents any reliable assessment of risk-adjusted returns or true strategy robustness. Immediate action requires increasing the trade frequency or switching to a higher volatility interval to gather sufficient historical data for valid validation. Until the sample size expands to at least fifty trades, this configuration remains unqualified for institutional consideration.
