The BKNG GG7 Williams Oversold backtest shows a +12.03% ROI on only three trades, which is insufficient data to claim statistical significance. A 33.3% win rate paired with a 0.69 Sharpe ratio suggests the strategy is generating returns primarily through outlier wins rather than consistent edge. The 14.04% maximum drawdown confirms high volatility exposure that current risk parameters fail to mitigate. We must increase trade frequency or tighten stop-losses to validate if this alpha is repeatable. The next step is running a Monte Carlo simulation on these parameters to stress-test portfolio survival under market stress.
