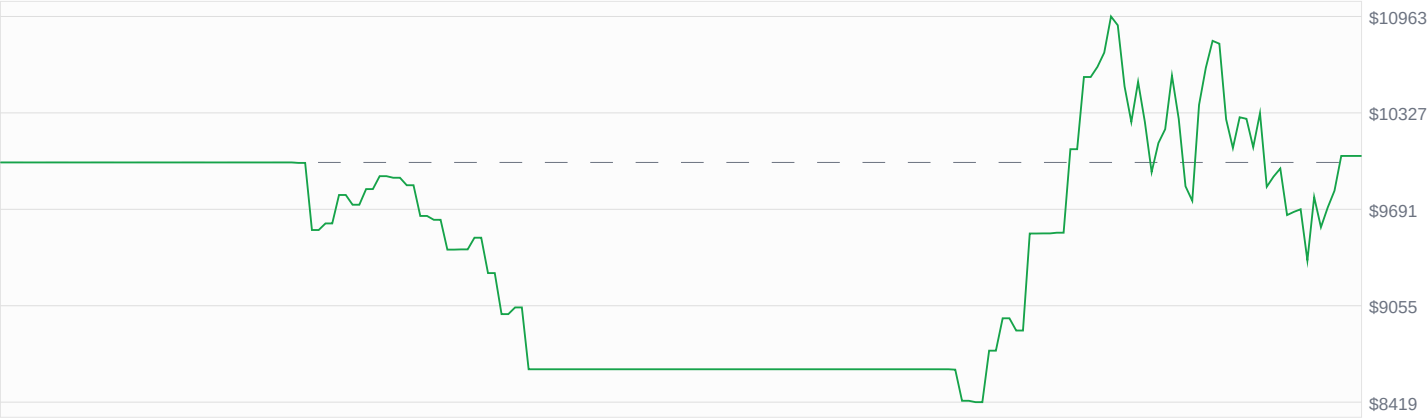

ANALYST NOTE

Hera local LLM

The EVO_GG1RSISNIP_v204 strategy on PLMR generated a nominal +0.43% return but failed to capture value due to a meager sample size of only two trades. With a Sharpe ratio of 0.14 and a max drawdown of 14.67%, the risk-adjusted profile indicates the strategy lacks statistical significance and suffers from high volatility relative to its gains. The 50% win rate is uninformative given the tiny dataset, meaning the current results could easily be random noise rather than a replicable edge. We must expand the backtest horizon or adjust parameters to accumulate sufficient trade data before deploying live capital.
