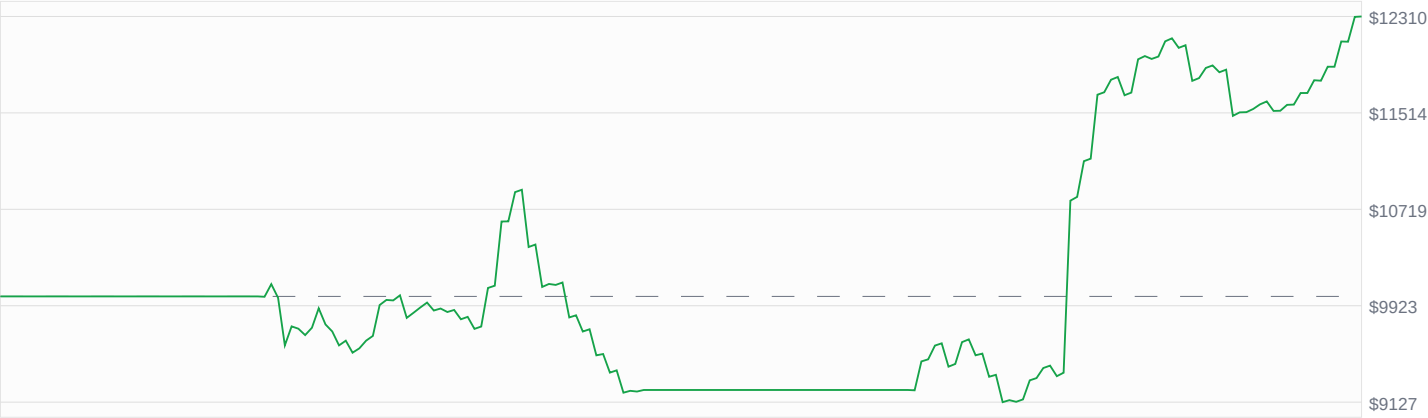

The EVO_GG1RSISNIP_v1018 backtest on MSFT shows a +23.06% ROI with a 1.19 Sharpe ratio, yet the 50% win rate and 14.24% drawdown highlight significant volatility. Statistical confidence remains critically low due to only two executed trades, rendering these metrics unreliable for live deployment. The strategy likely failed to capture sufficient trend duration or suffered from premature exits given the minimal trade count. Immediate next steps require stress testing the entry logic across multiple market regimes to validate robustness before capital allocation.
