The backtest shows a perfect 100% win rate, but with only two trades, the statistical significance is negligible and the results are highly prone to overfitting. While the 41.20% ROI and 1.21 Sharpe ratio look promising, the massive 32.83% drawdown indicates extreme volatility exposure that likely didn't survive a longer period. Such a small sample size cannot reliably predict future performance or confirm strategy robustness across different market regimes. The next step is to run a forward test on live data with tighter risk parameters to validate if the edge holds beyond this limited sample.
