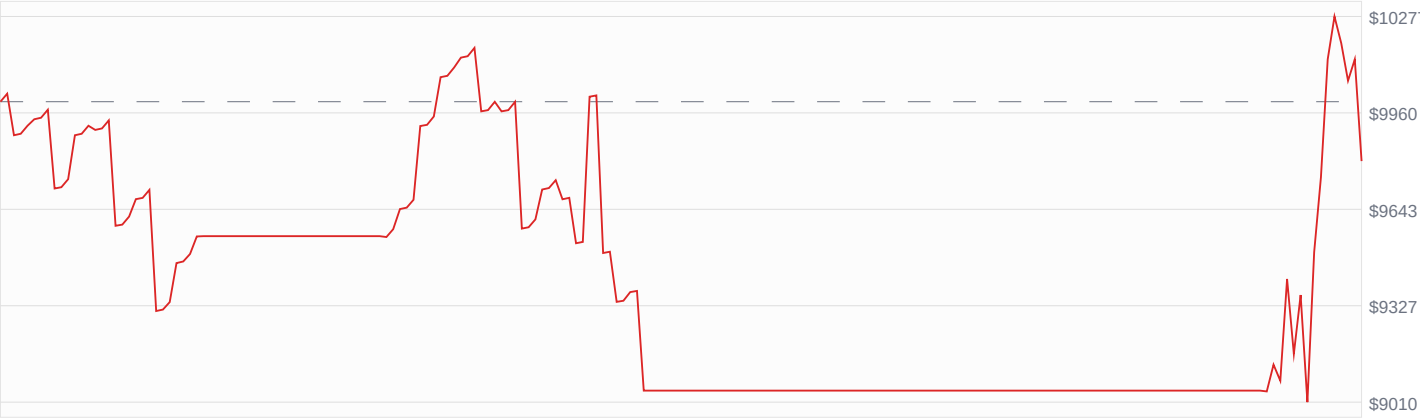

Hera local LLM

The EVO_EVOEVOE_v1908 strategy on VOXR failed to preserve capital, delivering a -2.01% return with a negative Sharpe ratio of -0.05 across only three trades. A 33.3% win rate and an 11.32% maximum drawdown suggest the signal logic lacks robustness in the current volatility regime. Statistical confidence remains negligible due to the tiny sample size, making any performance claim meaningless without further data. We must increase backtest depth and adjust entry filters to validate the core hypothesis before live deployment.
