Hera local LLM

The backtest on AMD shows an 87.88% return but relies on only two trades, rendering the 1.61 Sharpe ratio and 50% win rate statistically insignificant. A 26.05% drawdown indicates high volatility exposure that requires wider validation before any live deployment. We must execute a larger sample size simulation to confirm whether this outlier performance is reproducible rather than luck. Next, run a walk-forward analysis across ten years of AMD data to stabilize the equity curve and filter noise. This approach ensures the strategy has genuine edge before risking real capital.
