The EVO_EVOEVOEVOE_v697 backtest on BWB generated a modest +2.15% ROI but suffered from a critically low Sharpe ratio of 0.25 and a sharp 13.41% drawdown. With only three trades executed, the sample size is statistically insufficient to confirm the strategy's viability or the observed win rate of 33.3%. The data suggests the current parameters are overly sensitive to noise, resulting in frequent false signals and poor risk-adjusted returns. We must expand the testing horizon to at least 200 trades before considering live deployment. A concrete next step involves narrowing the entry criteria to filter out low-probability setups and reduce transaction costs.
