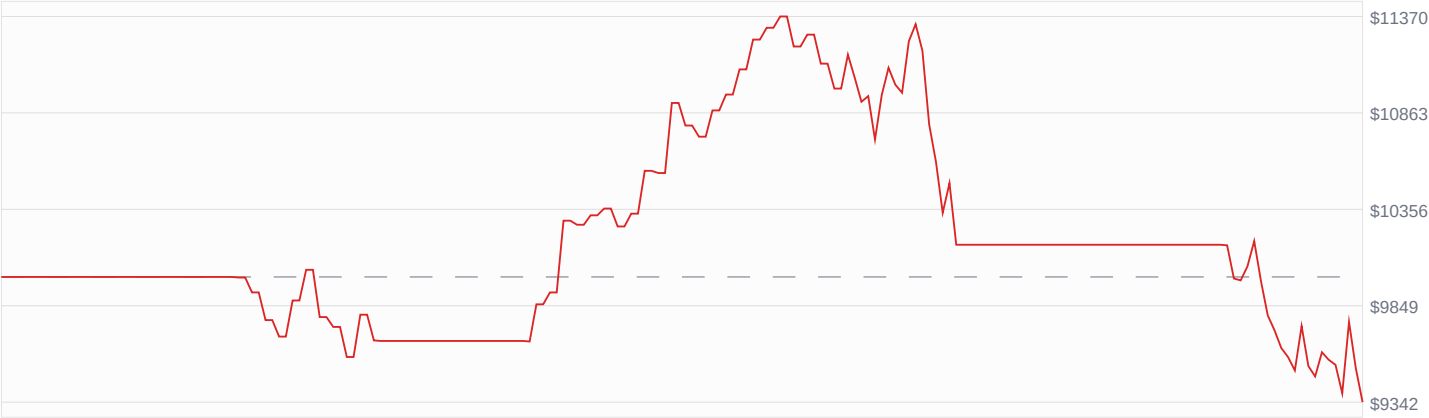

The EVO_GG1RSISNIP_v958 strategy on AMZN failed decisively, delivering a -6.61% ROI with a negative Sharpe ratio of -0.47. A 17.84% max drawdown and 33.3% win rate across only three trades indicate insufficient statistical significance to validate the edge. The sample size is too small to distinguish between random noise and genuine strategy failure, leaving the risk profile undefined. Immediate action requires expanding the backtest window to a larger sample size before any live deployment is considered.
