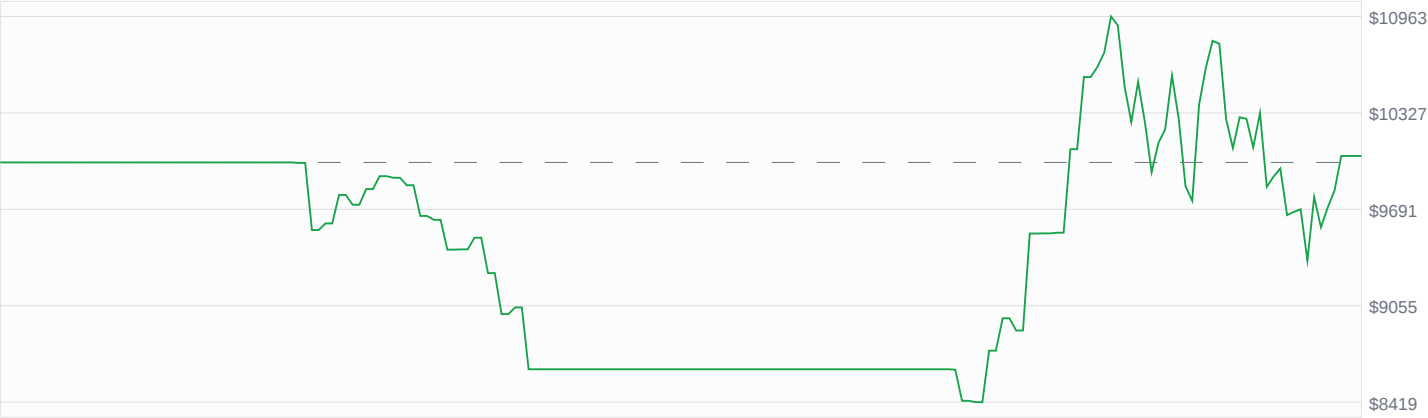

The EVO_GG1RSISNIP_v1032 backtest on PLMR yielded a marginal +0.43% ROI with a negligible Sharpe ratio of 0.14, indicating a strategy that barely outperformed a risk-free rate. With only two trades executed, the 50% win rate and 14.67% maximum drawdown lack statistical significance and suggest the strategy is currently undercapitalized or overfitted to noise. The limited sample size prevents any reliable assessment of risk-adjusted returns or true market resilience. Immediate optimization of entry filters or a minimum capital threshold is required before re-evaluating performance metrics.
