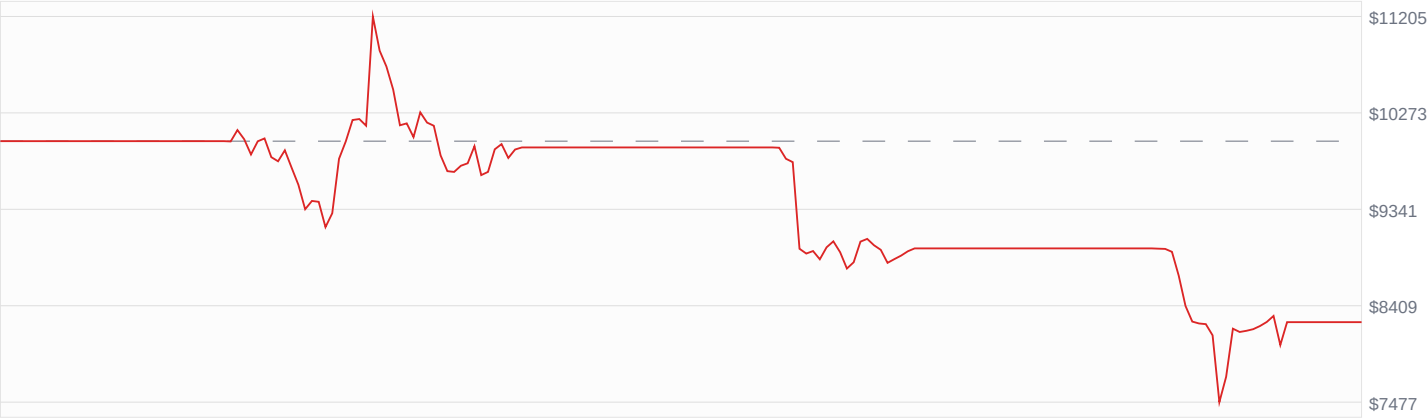

The EVO_GG1RSISNIP_v1117 strategy on META produced catastrophic results with a -17.5% ROI and zero winning trades, indicating a severe structural flaw or overfitting to a very small sample. With only three trades executed, the statistical confidence is negligible and the -0.85 Sharpe ratio suggests the model is generating consistent losses rather than navigating volatility. Such a deep drawdown of 33.28% implies the stop-loss logic or entry conditions are fundamentally misaligned with current market microstructure. Before redeploying capital, a rigorous parameter sweep and out-of-sample validation are mandatory to identify the root cause of this failure. This strategy is currently unfit for live trading and requires immediate algorithmic revision.
