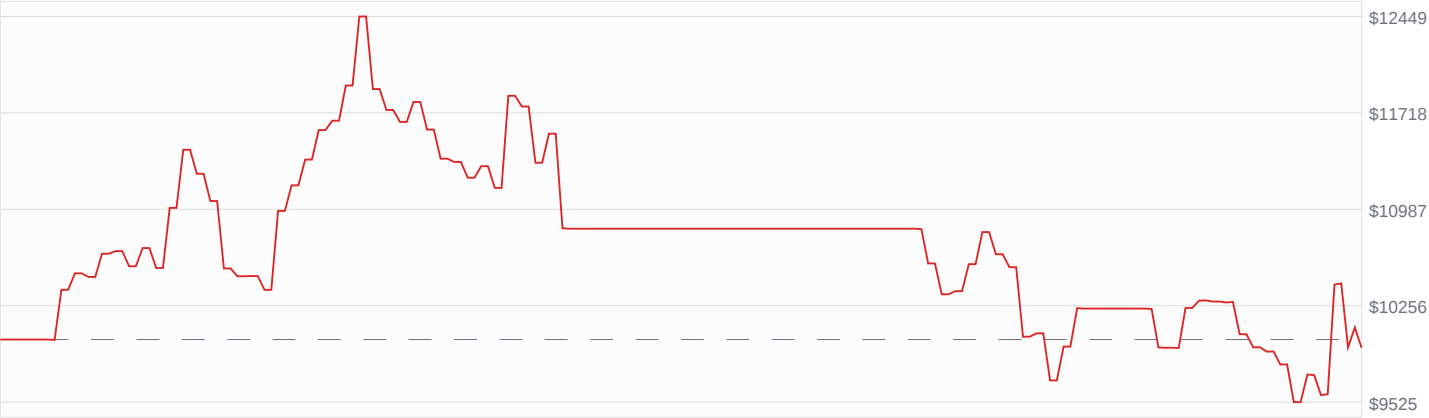

ANALYST NOTE

The EVO_GG1RSISNIP_v1195 backtest on NVDA failed to generate alpha, delivering a negative ROI of -0.66% with a minimal Sharpe ratio of 0.09. Such a sample size of only three trades lacks statistical significance, rendering the 33.3% win rate and 23.49% drawdown unreliable for risk modeling. The strategy appears overly sensitive to recent price action, failing to capture the broader institutional flow in the semiconductor sector. A concrete next step is to widen the lookback period for entry signals to smooth out noise and validate the logic across a broader market cycle.
