The EVO_EVOEVOE_v1865 backtest on AAPL shows a +10.70% return with a 50% win rate, but the sample size of only two trades severely undermines statistical confidence. A 11.50% maximum drawdown combined with a Sharpe ratio of 0.87 suggests the strategy lacks sufficient risk-adjusted robustness for live deployment. The performance appears driven by outlier luck rather than consistent edge, making it unreliable for scaling capital. Immediate next steps involve expanding the backtest window to capture more market regimes or reducing trade frequency to validate signal stability. This analysis remains educational and does not constitute investment advice.
