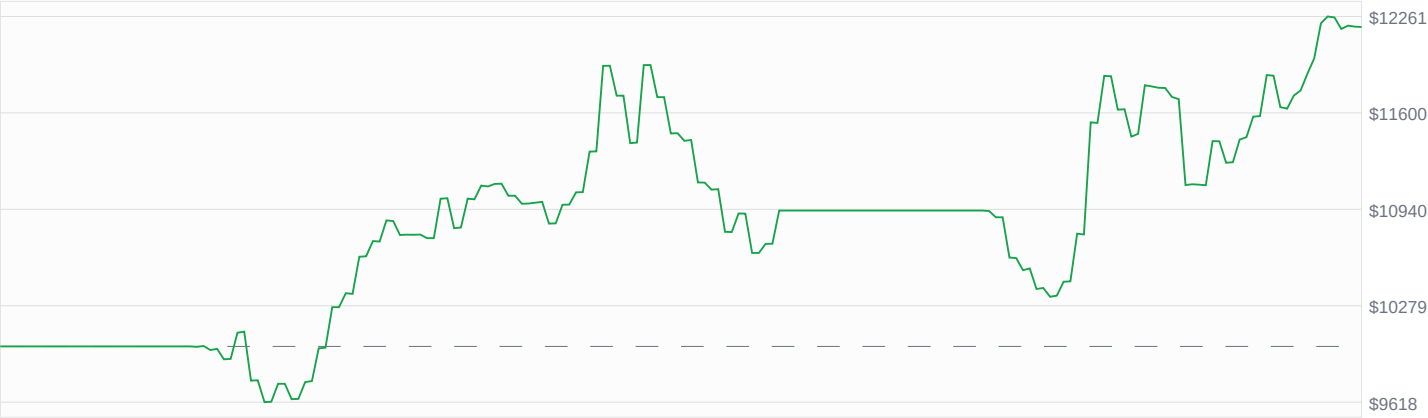

The SOLV GG9_ATR_Breakout backtest shows a +21.85% ROI and a perfect 100% win rate, but the sample size of only two trades renders the Sharpe ratio of 1.36 statistically insignificant. The strategy's 12.95% maximum drawdown indicates high volatility exposure that the ATR-based breakout logic failed to mitigate effectively. Given the lack of robustness, the current results cannot reliably predict future performance or support capital allocation. I will expand the backtest window to at least 100 trades to validate whether the edge persists across different market regimes.
