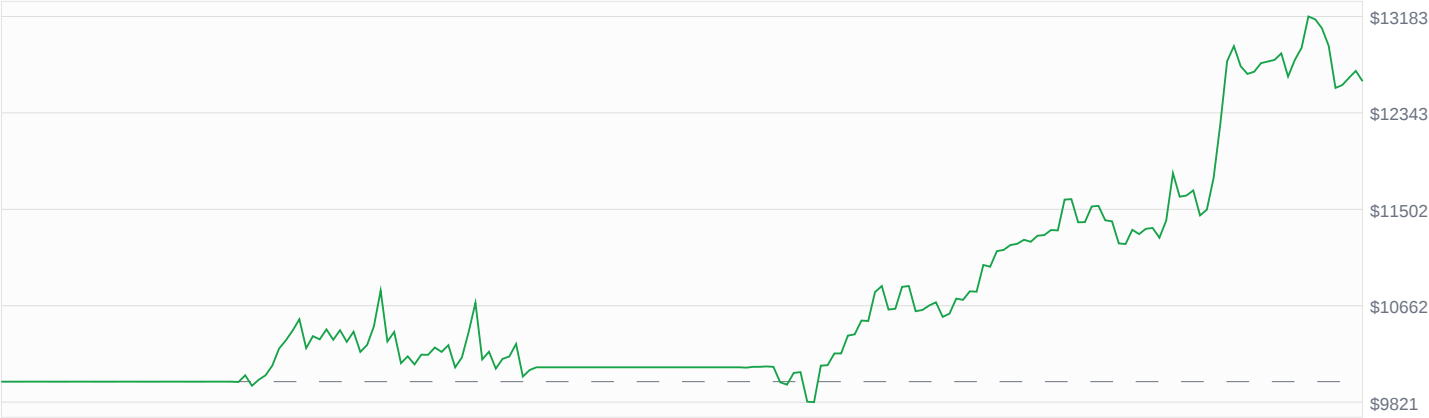

ANALYST NOTE

The HBT Zen Mean Reversion strategy shows a 26.15% return with a pristine 100% win rate, but this statistical perfection is highly suspect given only two trades. A max drawdown of 7.38% combined with a Sharpe ratio of 1.70 suggests potential overfitting or a lack of robustness against market regime shifts. Without sufficient trade volume to validate performance, the strategy lacks the statistical confidence required for institutional deployment. The immediate priority is expanding the backtest window or adjusting entry filters to generate a statistically significant sample size.
