The EVO_EVOEVOEVOE_v2387 backtest on PLMR shows a negligible 0.43% return with a dangerously low Sharpe ratio of 0.14, driven by only two trades that severely limit statistical confidence. A maximum drawdown of 14.67% indicates significant volatility exposure, while a 50% win rate offers no edge over random chance. This strategy fails to demonstrate robust risk-adjusted performance and lacks the sample size required for any institutional validation. The next step is to run a longer historical simulation to verify if the poor metrics stem from recent market conditions or inherent strategy flaws.
