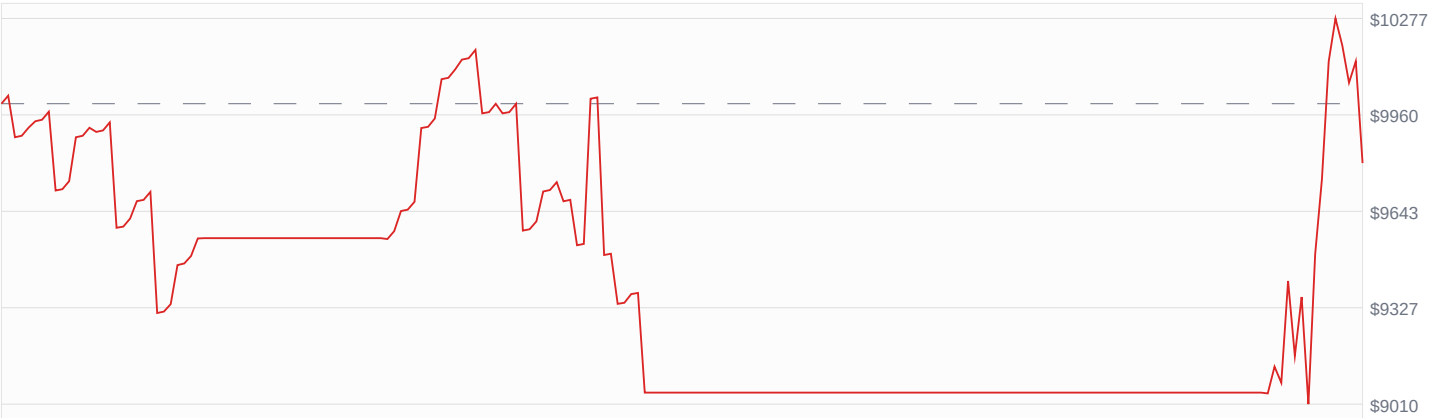

ANALYST NOTE

Hera local LLM

The EVO_EVOEVOEVOE_v1721 strategy on VOXR failed decisively, posting a -2.01% ROI and a negative Sharpe ratio of -0.05, signaling a net loss of value. With only three trades executed, the sample size is statistically insignificant, rendering the 33.3% win rate and 11.32% drawdown unreliable metrics for live deployment. The strategy lacks the robustness required for institutional standards and produced no alpha during this simulation period. Immediate recalibration of entry filters or a complete pivot to a different asset class is necessary before reconsidering this approach.
