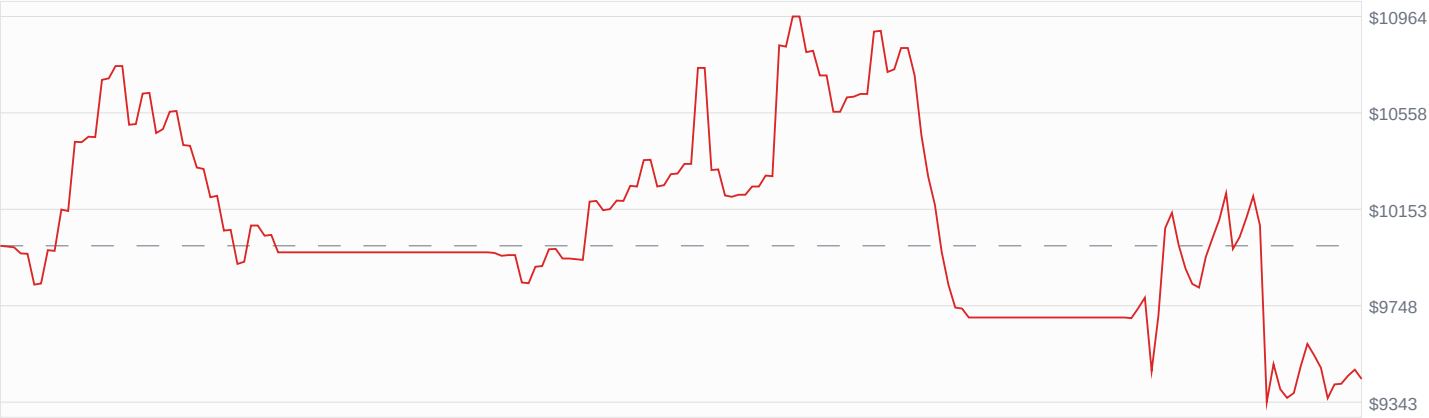

ANALYST NOTE

Hera local LLM

The RDN backtest for EVO_EVOEVOE_v1786 failed catastrophically with a zero percent win rate across only three trades, rendering the Sharpe ratio of negative 0.31 statistically meaningless. A maximum drawdown of nearly fifteen percent indicates severe exposure to adverse price action that the strategy logic failed to mitigate. Such a small sample size provides no confidence in the strategy's viability and likely reflects overfitting to a specific market regime. The approach requires immediate parameter optimization or a complete rewrite of the entry logic before any further simulation.
