The EVO_EVOEVOE_v2144 backtest on MSFT shows a +20.07% ROI but lacks statistical significance due to only two trades. A 50% win rate with a +1.06 Sharpe ratio is unconvincing without a larger sample size to validate consistency. The 14.24% maximum drawdown suggests elevated volatility risk that requires stress testing against broader market conditions. Before deploying live capital, you must run a parameter optimization study on at least 100 trades to filter noise.
