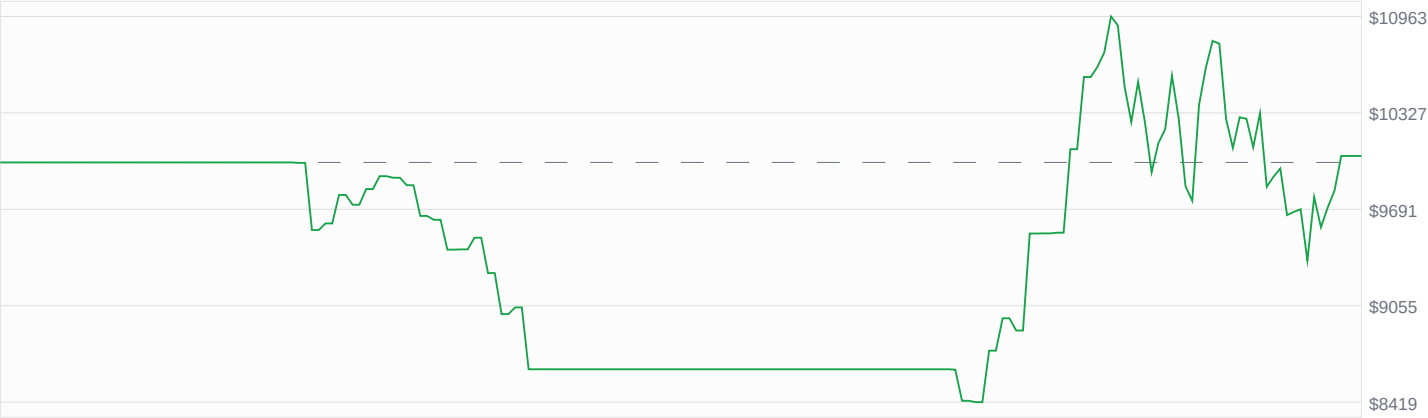

The EVO_EVOEVOEVOE_v2254 backtest on PLMR shows marginal gains with a 0.43% ROI and 50% win rate, but the sample of only two trades renders statistical significance impossible. A 14.67% maximum drawdown against a Sharpe ratio of 0.14 indicates severe instability and poor risk-adjusted returns. Such limited data cannot confirm strategy robustness, suggesting the approach is currently overfitted or simply non-functional. We must immediately execute a new simulation with a minimum of 1,000 trades to validate any edge before live deployment.
