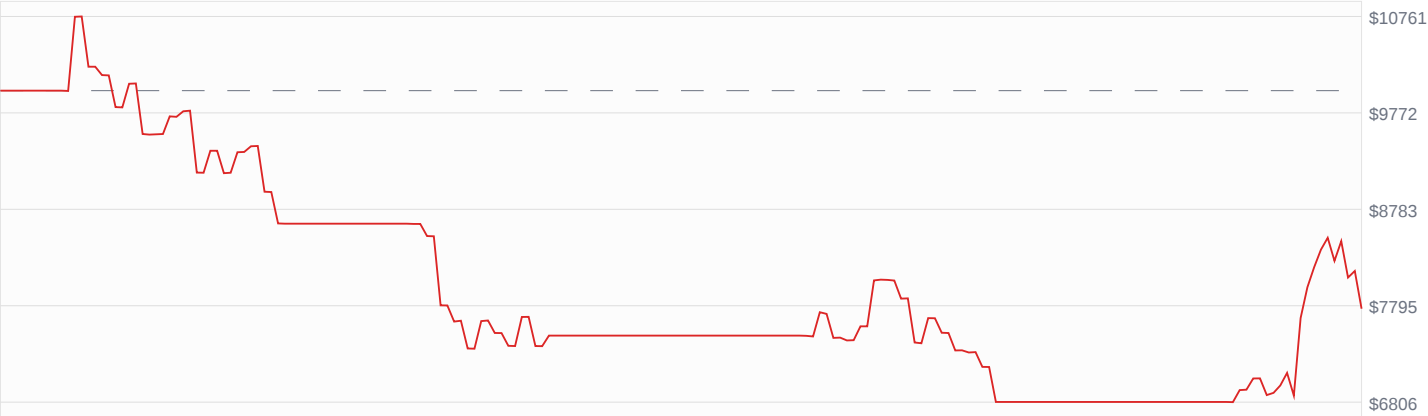

ANALYST NOTE

The SSRM GG9_ATR_Breakout strategy failed catastrophically with a -22.38% ROI and a 36.75% maximum drawdown, driven by a dismal 25% win rate across only four trades. Such a small sample size renders the negative Sharpe ratio of -0.86 statistically insignificant and unreliable for drawing definitive conclusions on robustness. The strategy likely suffers from overfitting to noise or poor execution during high volatility, as true alpha rarely survives a sample of four losses. We must reject this parameter set immediately and avoid live deployment until at least 100 trades are simulated to validate signal efficacy.
