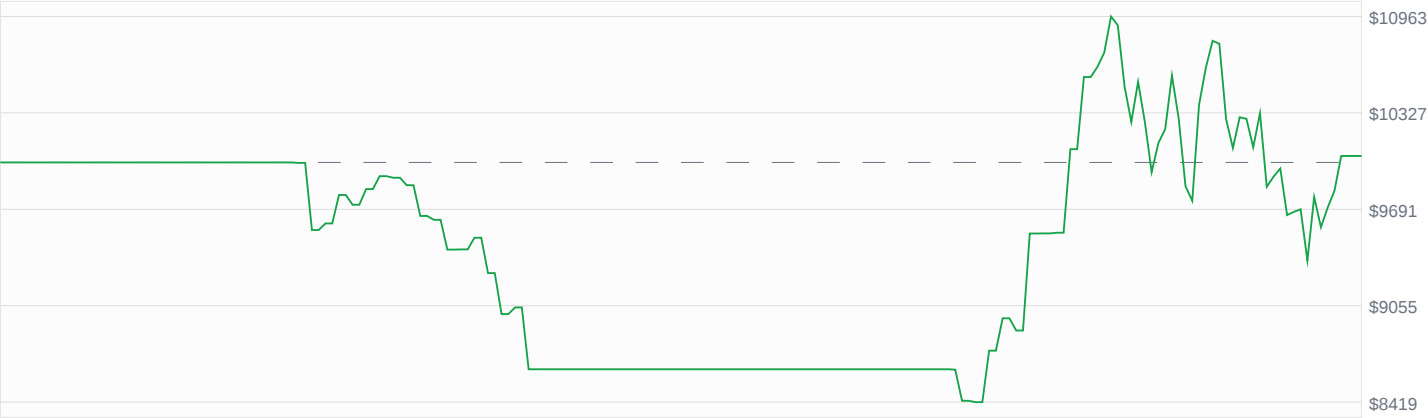

ANALYST NOTE

Hera local LLM

The EVO_WEBIDEA_v2369 backtest on PLMR shows statistically insignificant results with only two trades, rendering the 0.43% ROI and 0.14 Sharpe ratio unreliable for decision-making. A 50% win rate and 14.67% drawdown suggest the signal logic lacks robustness during low-volume periods or market noise. Given the extremely small sample size, the strategy fails to demonstrate consistent edge or risk-adjusted performance required for institutional deployment. We must increase the lookback period for parameter optimization or switch to a higher-frequency interval to gather sufficient trade data for validation. This test alone is insufficient to justify live capital allocation without further stress-testing across different market regimes.
