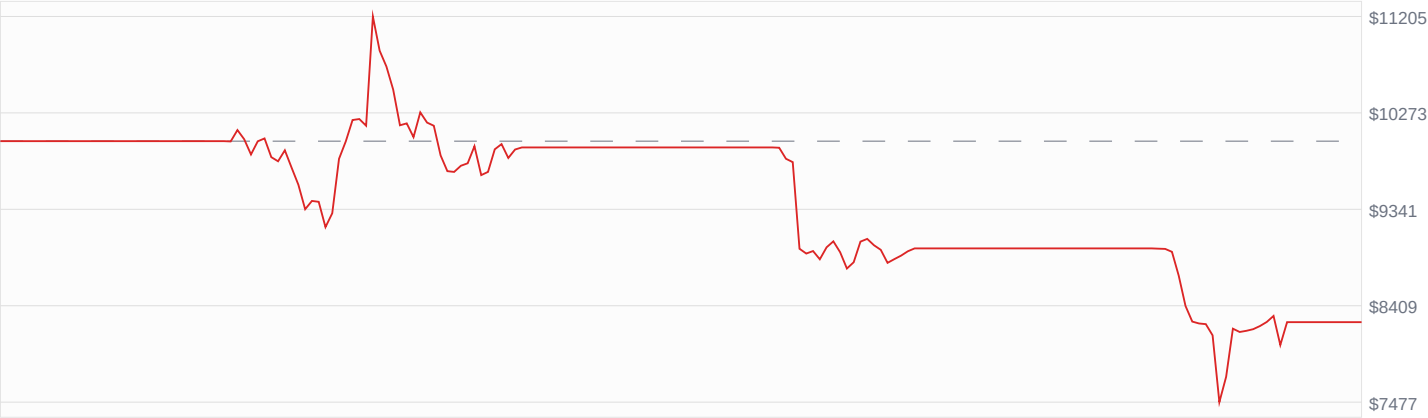

The EVO_EVOEVOE_v562 strategy on META is a statistical failure, registering zero winning trades and a catastrophic 33.28% drawdown. With only three executed trades, the sample size is insufficient to generate reliable p-values or validate any alpha signal. A negative Sharpe ratio of -0.85 confirms that the strategy generated returns significantly worse than a risk-free asset during this simulation. The failure to capitalize on any setup suggests the entry logic requires immediate parameter re-optimization or a fundamental rule change. Before redeploying capital, a rigorous walk-forward analysis is required to ensure robustness against overfitting.
