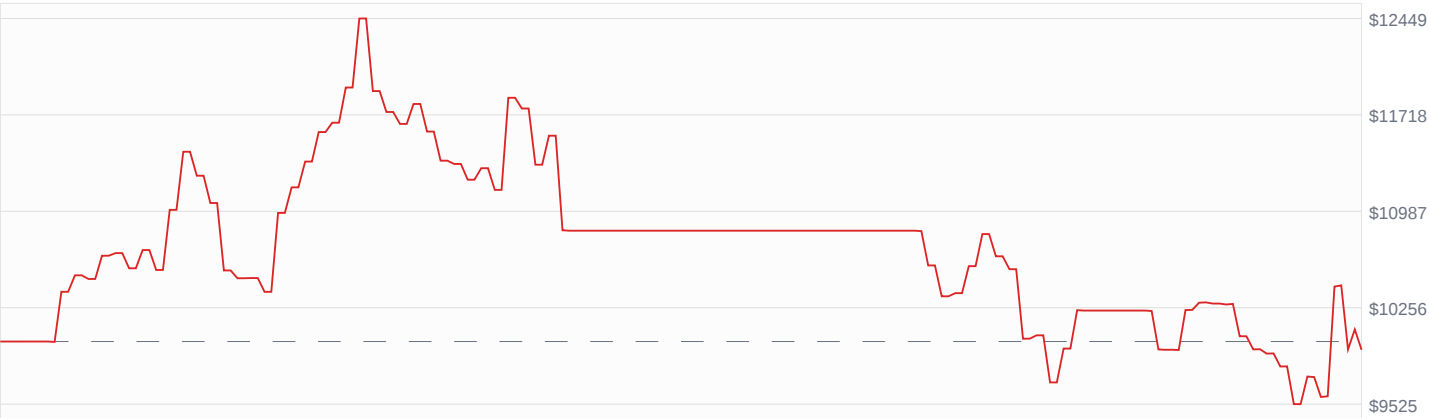

ANALYST NOTE

The EVO_GG1RSISNIP_v332 strategy failed to generate alpha on NVDA, posting a negative ROI of -0.66% with a meager Sharpe ratio of 0.09. A 33.3% win rate and a severe 23.49% maximum drawdown indicate poor risk-adjusted performance and significant volatility exposure. With only three trades executed, the sample size is statistically insignificant, rendering any positive signal interpretation unreliable. The strategy requires immediate parameter re-optimization or a complete logic revision before further deployment. Do not scale this approach until robustness is proven over a larger dataset.
