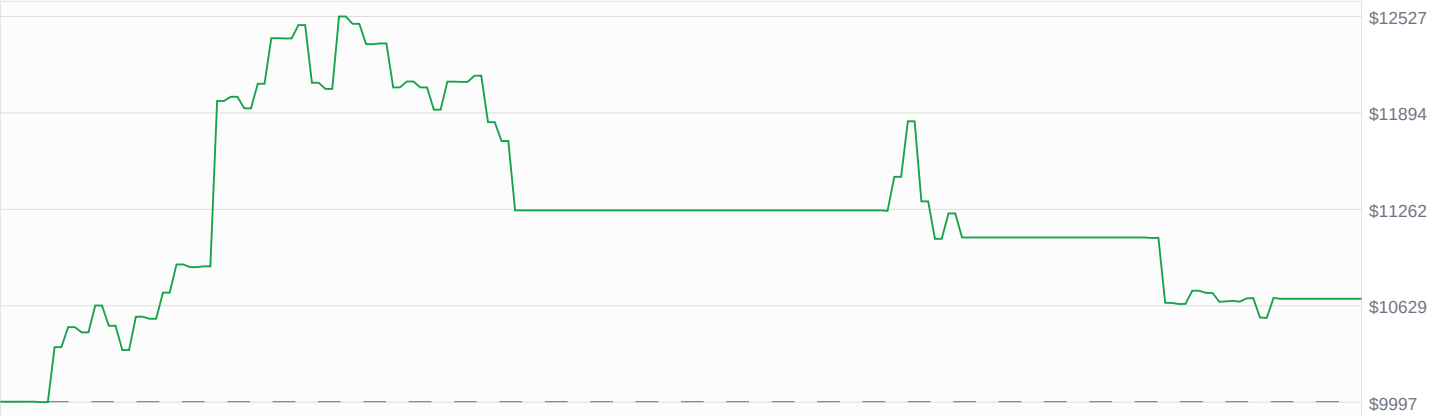

The EVO_GG1RSISNIP_v295 backtest on GOOGL yielded a +6.75% return, yet the statistical significance is negligible given only three executed trades. A 33.3% win rate paired with a sharp 15.79% drawdown indicates high volatility and insufficient sample size to validate the strategy's robustness. The low Sharpe ratio of 0.54 suggests the risk-adjusted returns are underwhelming relative to the capital exposure taken. To build confidence, run a parameter optimization sweep on entry thresholds to identify if a more stable regime exists. This analysis remains educational and does not constitute investment advice for specific trades.
