The backtest shows a perfect win rate, but this is statistically insignificant with only two trades, creating a false sense of security. A 32.83% maximum drawdown combined with a modest Sharpe ratio of 1.34 suggests the strategy lacks robustness against adverse price action. The high ROI stems from a small sample size rather than a proven edge in market dynamics. You must run a longer backtest on additional data points or adjust entry filters to validate the strategy before live deployment.
