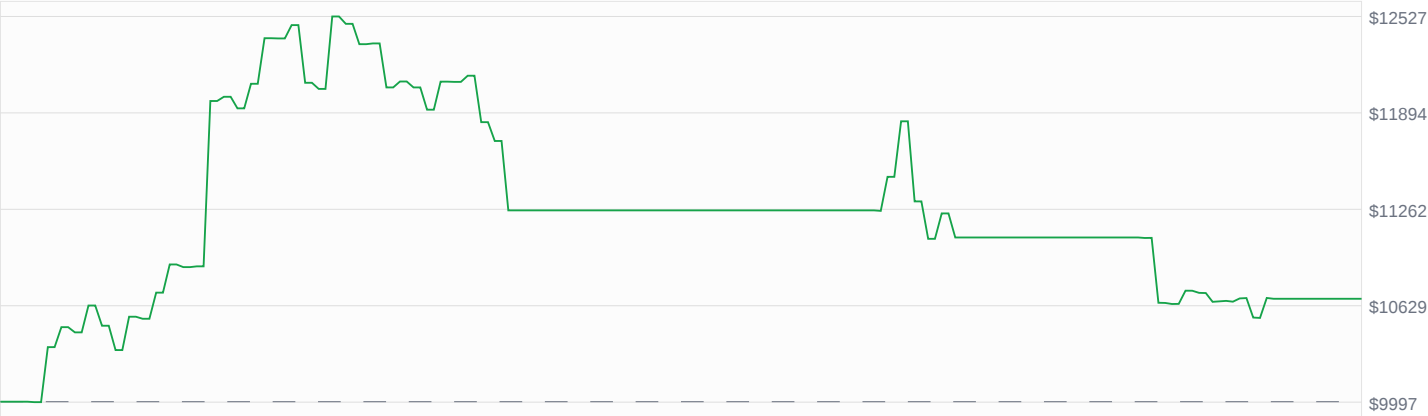

ANALYST NOTE

Hera local LLM

The EVO_GG1RSISNIP_v295 strategy on GOOGL generated a modest +6.75% return with a low Sharpe ratio of 0.54, indicating that gains were not sufficiently compensated by the risk taken. With only three trades executed, the 33.3% win rate and 15.79% maximum drawdown provide statistically insignificant evidence of a robust edge. The sample size is far too small to confirm stability, and the drawdown suggests potential vulnerability during adverse market moves. We must execute a larger out-of-sample test across different market regimes before deploying real capital.
