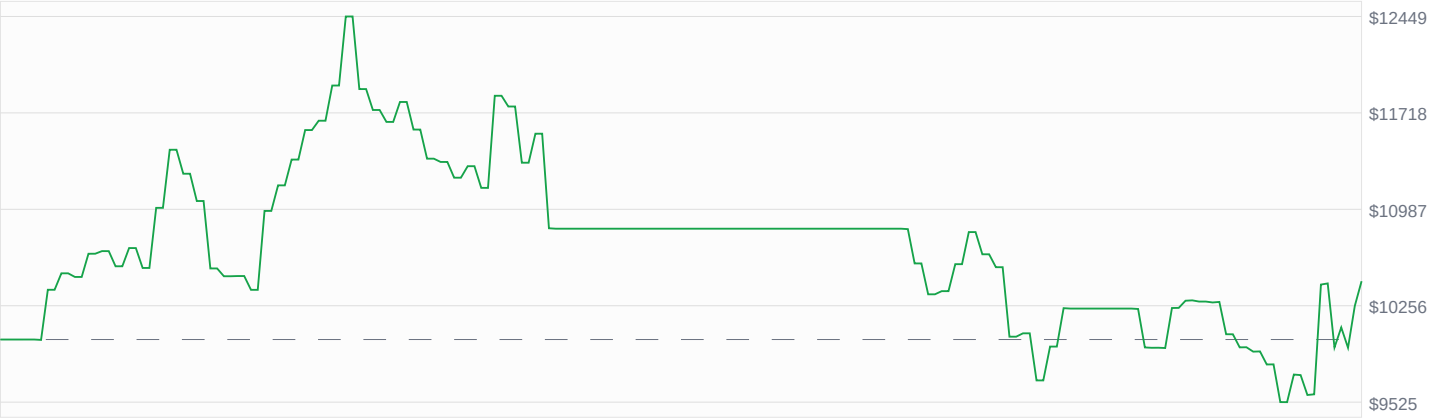

ANALYST NOTE

Hera local LLM

The EVO_EVOWEBIDEA_v418 backtest on NVDA generated a nominal gain with a 66.7% win rate, yet the statistical confidence is critically low due to only three total trades. A maximum drawdown of 23.49% indicates high volatility exposure that the Sharpe ratio of 0.34 fails to adequately penalize given the small sample size. The strategy appears to be capturing noise rather than a robust trend, as the limited trade count prevents reliable assessment of true performance. You should run this bot on a daily timeframe with at least one hundred trades before deploying any capital to validate edge.
