The RDN backtest for EVO_EVOGG1RSIS_v434 failed catastrophically with zero winning trades and a negative Sharpe ratio, indicating the strategy generates alpha in the wrong direction under current market conditions. With only three trades executed, the statistical sample size is insufficient to confirm a permanent flaw, yet the 14.78% peak drawdown suggests significant tail risk exposure that demands immediate review. The total loss of over 5% confirms the approach is currently unprofitable and contradicts institutional risk thresholds. I recommend re-running the simulation with adjusted stop-loss logic to test robustness before considering live deployment.
